

Lithium battery pack custom export

What types of batteries can be custom made?

According to different requirements, Li-ion, Li-po, Ni-Mh battery pack can be custom made. Consumer Electronics, Intelligent Household, Power Device (electric tools, toys, model aircraft, unmanned aerial vehicles (uavs), medical equipment, AGV robot, auto stop power supply).

Are lithium batteries considered hazmat?

Yes, all lithium batteries are classified as hazardous materials (hazmat). Therefore, they must be packed and labelled in a certain way and comply with safety standards.

Is FedEx a safe air courier for lithium batteries?

No. FedEx and UPS have their own, often stricter, safety requirements for lithium batteries in addition to those issued by IATA. IATA also releases yearly transportation safety requirements for international air transportation.

Do I need a test report for a lithium battery?

All Lithium batteries must be UN 38.3 compliant, and freight forwarders require that you present a test report before shipment. There are two ways to obtain a test report: 1. Submit a test report provided by the supplier. This only works if your supplier already has a UN 38.3 test report.

What is the cost of battery testing in China?

The cost of lab testing for batteries in China is around US\$350 to US\$500. Some Chinese suppliers may offer to submit the battery to a local testing company, but the test report may be worthless if it's not issued by an accredited testing company.

Do export cartons require a permanent remark?

The export cartons must have a permanent (printed) freight remark that includes the following information: ...
