

On strengthening power grid peak load regulation and energy storage

What is peak-regulation capability of a power grid?

Principle of the evaluation method The peak-regulation capability of a power grid refers to the ability of power supply balancing with power load, especially in the peak load and valley load periods. Specifically, the adjustment range of power supply in one day should be high enough to reach the peak load and low enough to reach the valley load.

What is peak load regulation?

To balance the peak-valley (off-peak) difference of the load in the system, the power system peak load regulation is utilized through adjustment of the output power and operating states of power generator units in both peak and off-peak hours.

What is the optimal scheduling model for power system peak load regulation?

Conclusion This paper presented an optimal scheduling model for power system peak load regulation considering the short-time startup and shutdown operations of a thermal power unit. As the main resource on the generation side, the intrinsic capacity of the thermal units in the system peak load regulation was studied in this paper.

How effective is peak-load regulation capacity planning?

Based on probabilistic production simulation, a novel calculation approach for peak-load regulation capacity was established in Jiang et al. (2017), which is still effective for peak-regulation capacity planning when some information of renewable energy and loads is absent.

Does energy storage system contribute to grid-assisted peak shaving service?

At present, the research on the participation of energy storage system in grid-assisted peak shaving service is also deepening gradually [4, 6, 7, 8, 9, 10]. The effectiveness of the proposed methodology is examined based on a real-world regional power system in northeast China and the obtained results verify the effectiveness of our approach.

Can peak load regulation cost of thermal units be integrated into optimal scheduling?

In addition, an integrated optimal scheduling model for power system peak load regulation with a suitable rolling optimization strategy was proposed. To the best of our knowledge, this study is the first to integrate different modes' peak load regulation cost of thermal units into the optimal scheduling model.
